receipt of settlement amount, the Second Party shall have no claim of whatsoever nature including re-instatement, backwages, provident fund, gratuity, bonus and any other benefits and all his claims regarding any kind of past, present and future benefits of her employment with the First Party shall stand settled and satisfied fully and finally. The Second Party agrees that he will not raise any such claim in future before any Forum with regard to him employment i.e. reinstatement, arrears of salary, gratuity, PF, bonus, compensation etc.

- (f) It is agreed that the Provident Fund lying deposited with the Provident Fund department shall be released to the Second Party and the First Party shall cooperate for the same.
- (g) Both the Parties shall pray to the Hon'ble Delhi High Court that the present \_\_\_\_\_ may be disposed off in terms of the present Settlement Agreement, and all claims, including Award dated \_\_\_\_\_, may have been declared as fully satisfied, for which both the parties have already agreed upon and have given their undertaking to do so.
- 9. By giving consent to this Settlement Agreement, the parties hereto state that they shall have no further claims or demands against each other and all the disputes and claims have been amicably settled by the Parties hereto through the process of Mediation.
- 10. That the parties undertake before the Hon'ble Court to abide by the terms and conditions set out in the agreement and not to dispute the same hereinafter in future. The parties further agree and undertake that they shall

not resile from the present Settlement Agreement.

11. Both the Parties have agreed that they are entering into the present

Settlement Agreement voluntarily, out of their own free will and volition.

The Parties further state that they have understood the contents of the present

Settlement Agreement as the same have been explained to them and have

been read to both the parties in vernacular, by the mediators and their

respective counsels, in the presence of each other.
